FINANCIAL SECTOR STAKEHOLDERS COMMIT TO SUPPORT WOM WE FINANCE CODE HAS BEEN LAUNCHED





















ganda has officially joined the Women Entrepreneurs Finance Initiative (WE Finance Code or "the code") - a global commitment by financial service providers (FSPs), regulators, policymakers, development banks, and other financial ecosystem actors to expand access to finance for women-led micro, small, and medium enterprises.

Officially launched in October 2023 at the World Bank - IMF Annual Meetings in Marrakech, the Code is currently being implemented in over 30 countries worldwide, including Kenya, Rwanda, Nigeria, Tanzania, Senegal, Mozambique, Egypt and now, Uganda.

More than 350 FSPs have signed on to the initiative globally. The Code aims to expand women entrepreneurs' access to finance by bringing the private and public sectors to coordinate actions and policies at a National Level.

WHO WAS INVOLVED?

The launch event was hosted by the National Coalition comprising National Champions including the Ministry of Finance, Planning and Economic Development, Bank of Uganda (BOU) -who are also the national data aggregator, the Ministry of Gender, Labour and Social Development and the World Bank; National Coordinators/Secretariat including Private Sector Foundation Uganda (PSFU), Uganda Bankers Association (UBA) and Association of Microfinance Institutions of Uganda (AMFIU); and signatories - including financial service providers (commercial banks and microfinance entities) that signed the code (full list in colour panel).
