

Abategeka ebivvulu balina kusasula misolo gya ngeri ki?

BULI Lwakusatu, akulira ekitongole ekiwooza emisololo eky'URA ayankula ebibuuzo byammwe ku nsonga ezitali zimu. Ebibuuzo abyanukula ng'ayita mu lupapula lwo olwa **Bukedde**. Weereza ekibuuzo kyo ku nsonga yonna ku misolo n'obusuubuzi ku nnamba eno **0701625460** byonna ajja kubyankula.

Bwe mba njagala okutegeka ekivvulu mu nnaku enkulu, nnina kuwa misolo kika ki?

Ng'omutegesi w'ebivvulu, sooka weewandiise ku musolo owebwe TIN. Bw'otegeka ekivvulu, emisolo gino wammanga gye gitunuulirwa:

- Omusolo ku nnyingiza (Income Tax) nga guno guggyibwa ku magoba.
- Omusolo gwa VAT bw'oba ng'oyingiza ensimbi eziwera obukadde 37,5 mu myezi esatu egy'omuddiring'anwa oba obukadde 150 mu mwaka, nga guno guwozebwa ebitundu 18 ku 100 (18%) ku buli tikiti gy'otunda.
- Omusolo gwa Withholding Tax, tukusuubira okuggya kw'abo b'oba opatanye nabo okukuwa obuweereza mu kivvulu okugeza abakupangisizza ebidongo, nnannyini kifo, abatimbi, obulango bw'oyisa ku mikutu gy'empuliziganya n'abalala.

Lwaki kkampuni ezikola ku kuziika abafu teziggibwako musolo? Baba bataasa ki ng'ate nabo bali mu bizinensi?

Kkampuni ezikola ku kuwerekera abo Katonda b'ajjuludde zaaweewba obuweereza ku musolo gw'emmotoka ezitambuzi emibiri gy'abagenzi mu kiseera we zyingizibwa eggwanga, era y'ensonga lwaki ziba n'ennamba emmyuufu (ennamba z'emmotoka ezisonnyibwa omusolo). Okusinziira ku tteeka ly'omusolo gwa VAT, obuweereza bwa kkampuni ezikola mu kuwerekera abo Katonda b'ajjuludde tebuggyibwako musolo gwa VAT (Exempt). Ensonga lwaki obuweereza buno bwassibwawo, kwe kusikiriza abantu okuyingira obuweereza ekika kino obutaali mu ggwanga. Kyokka kkampuni zino zisasula omusolo ku nnyingiza yaazo (Income Tax).

Musinziira ku ki okugereka layisinsi za bizinensi kuba osanga omuntu alina bizinensi y'obukadde 20 ne 100 nga basasula layisinsi y'emu.

Obuvunaanyizibwa bw'okukusa olukusa w'okolera bizinensi (okugereka layisinsi) bwakwasibwa KCCA mu Kampala ne minisitule ya Gavummenti ezeebitundu ng'eyitira mu munisipaali, disitulikiti ne Town council.

Lwaki mufuna amawulire okuva ku bantu abatuli-raanye ababawa amawulire amakamu ku bitukwatako ne mutugereka omusolo mu bukuyamu? Ye bwe twekubira enduulu lwaki mulwawo okukitereza?

Enkola y'okuwooza omusolo mu ggwanga yeesigamizibwa ku muntu okwebala nga ye olwo n'atwanjulira bizinensi ye bw'ekoze (self-assessment). Bwe kisangibwa nga waliwo amagoba agaafunikawo, aba alina omusolo gw'alina okusasula. Nnannyini bizinensi bwe yeesuulirayo ogwa nngaggamba, ne tufuna okutemezebwa omuntu yenna, tubalirira omusolo ku bizinensi ye nga tuyita mu mateeka, oluvannyuma ne tumusaba asasule omusolo oluusi ogubaamu amagoba n'engassi. Omuntu oyo bw'aba alina okwemuluganya ku musolo ogumugerekeddwa, alina eddembe okwekubira enduulu obutasukka nnaku 45 okuva lw'agererwa omuwendo gw'atakiriziganya nagwo. Kino kikolebwa okuyita ku kibanja kyaffe (web portal), mu akawunti ye eya TIN. Wano, okuddibwamu kusubirwa mu nnaku 90 oluvannyuma,

lw'okufuna okusaba kwe.

Gavumnti (Auditor General), nga n'abeenyigira mu kuwuwuttanya ensimbi y'omuwi w'omusolo balondoolwa kaliisoliiso wa Gavumnti (Inspector General of Government).

Abatunda mu tonninyira lwaki tuggyibwako empooza?

Lwaki abakazi abatunda mu tonninyira ku makubo batuggyako empooza ya buli lunaku mu kifo ky'okutusasuzza omwezi?

Obuvunaanyizibwa bw'okugereka empooza bugwa mu kitongole kya KCCA ne minisitule ya Gavumnti ezeebitundu.

Ojja kulambulwa okukakasa okutuukawo kw'obuzibu buno, oluvannyuma TIN yo egguyibweko omusolo ku nnyingiza eva mu bipangisibwa (Rental Income Tax). Lwaki amasomero g'obwannannyini mugaggyako omusolo munene?



Lwaki amasomero g'obwannannyini mugaggyako omusolo munene ng'ate gatuyamba okutuusa obuweereza ku bantu?

Amasomero g'obwannannyini, Gavumnti gye buvuddeko yagawa ku buweereza olw'omulimu ettendo gwe gatuyamba ku Banayuganda nga kino kyamala emyaka etaano (okuva mu 2008 okutuuka mu 2013). Obuweereza buno bwabaweewba olw'ensimbi ze baali batadde mu byenjigiriza ekiseera ekyo. Mu kiseera kino, omusolo omukulu ku masomero gwegwo oguwozebwa ku nny-

ingiza yaago (Income Tax). Ebika by'omusolo ebirala tebisasulwa masomero butereevu okugeza omusolo ku musaala gw'abakozi b'essomero, ogwa Withholding Tax nga guno guggyibwa kw'oyo aba atuusizza obuweereza ku somero, ng'omuwendo gw'obuweereza gusukka akakadde kamu.

Jjukira nti Gavumnti yassa n'obuweereza ku bimu ku biyamba mu kusomesa ku nsonga y'omusolo gwa VAT (ku bitundu 0 ku 100 (0%) n'ekigendererwa ky'okufuna ebikozesebwa bino ku nsimbi ensaamusaamu.
