Enkola eno empya tefuula kuyingiza byamaguzi na kusasula musolo kya bbeeyi?

Nedda. Lwa nsonga nti, kino kiyambako omusuubuzi okwesasulira omusolo gwe awatali kubuzaabuzibwa. Jjukira nti emabegako, omugugu ogumu mu konteyina bwe gwabeerangako obuzibu oba omu ku basuubuzi n'alemererwa okufuna ensimbi z'okusasula omusolo mu budde, kyalwisangawo konteyina yonna, ekintu ekitasoboka mu nteekateeka eno empya.

Ebiwandiiko bye weetaaga okukiriyalinga ebyamaguzi kuliko Invoice kwe byagulirwa, bill of lading n'ekiwandiiko ky'olukalala lw'ebyamaguzi ebyo ekimanyiddwa nga packing list. Teweerabira nti weetaaga okuba ne TIN yo okusobola okutuukiriza kino.

ENKOLA gye mpulira eya individual House Bill etegeza ki era erina njawulo ki n'eyo ebaddewo?

Enkola ya Individual House Bill yaleetebwa okugonjoola engeri abantu abayingiriza ebyamaguzi awamu mu nkola emanyiddwa nga groupage gye basasulamu omusolo. Emabegako, omuntu omu yakung'aanyanga abasuubuzi ab'enjawulo abayingiza ebyamaguzi ebitonotono, n'abiyingiriza mu konteyina emu.

Bwe byatuusibwanga e Mombasa, ng'oyo abiyingiriza akiriyalinga omusolo gw'abasuubuzi bonna abeegattidde mu konteyina ku kiwandiiko kimu ekimanyiddwa nga Master Bill of Lading, ng'akozesa TIN ye.

Enkyukakyuka eyaleetebwa eri nti, oluvannyuma lw'okutuusa konteyina omuli ebyamaguzi by'abasuubuzi ab'enjawulo, buli musuubuzi aweebwa ebyamaguzi bye n'ekiwandiiko kya Individual House Bill of Lading ne yeesasulira omusolo ogumugerekeddwa ku bintu bye.

Buli mubaka wa Palamenti kimukakatako okusasula omusolo ku musaala gwe buli mwezi. Embala y'omusolo esenziira ku bungi bw'omusaala omubaka gw'afuma, nga wano we tusenziira okumuggyako omusolo. Mu kukola kino, tugendereramu okussaawo obwenkanya mu kusasula omusolo nga bwe kiri ku bakozi abalala (ng'oggyeeko abo abaasonyiyibwa okusasula omusolo ku misaala gyabwe).

Mwebale aba URA okutusomesa ku by'emisolo buli kadde.

Naye lwaki abakozi bammwe basusse obukambwe nga batukwata?

Si nkola ya URA okutulugunya abawi b'omusolo, oli ne bw'aba ng'azzizza omusango ku nsonga z'omusolo. Mu mbeera eno, tuteekeddwa okumuyisa mu nkola y'obuntubulamu ng'amateeka bwe galagira. Noolwekyo, bwe weesanga nga waliwo abakozi ba URA abakuyisizza obubi, osobola okutuukirira ku namba y'essimu, 0772141075 oija kuyambibwa.

Kino kiri bwe kityo kubanga ng'ekitongole, tulina abavunaanyizibwa ku kukwasisa empisa eri abakozi baffe be ziba zisiwuu-seeko.

Kituufu nti URA esala omusolo ku ssente za NSSF ze bawa omuntu ng'awummudde?

URA teggya musolo ku nsimbi za NSSF omukozi yenna z'aba yeeterekedde. Kino kiri bwe kityo kubanga ensimbi zino we ziterekebwa, ziba ziggyiddwaako omusolo. Noolwekyo, mu kiseera ky'okuwummula, nnyini zo zimu-weebwa bulambalamba.

Ssebo kamisona, nsaba nga URA mututeerewo enkola y'okutuzimbira amayumba ng'ekitongole nga bwe tusasula mpola.

Tweyanzizza ekiteeso ky'oleese eky'okuzimbira Bannayuganda

eyo tesasulirwa musolo, kyokka waliwo ekiwandiiko ekissibwako omukono oyo aba aweereddwa olukusa okulabirira ebyobugagga by'omugenzi, nga kino kimanyiddwa nga Administration Bond. Kino okukikakasa ng'ekiwandiiko ekikkirizibwa mu mateeka, kisasulirwa omusolo gwa Stamp Duty gwa 15,000.
